INSTRUCTIONS FOR ISSUING A SUBPOENA

When a request for a subpoena is filed with the clerk's office, the following items must be included:

- A check made payable to Miamisburg Municipal Court for \$10.00 per subpoena requested.
- A check made payable to the witness ordered into court for \$0.505 per mile plus \$6.00 for each half day.
- You will find a blank subpoena listed under the "Prescribed Forms" tab on the website. A completed subpoena must be submitted with the payment.
- Please be sure to submit your request in a timely manner to provide ample time for service prior to the scheduled court date.
